### ARE YOU INTERESTED IN ATTENDING NORTHEASTERN UNIVERSITY?

If you are a **graduating high school senior or transfer student** currently living in BHA public housing, you are eligible for a full tuition scholarship.



#### TO APPLY, YOU MUST SUBMIT:

1. The Common Application, which can be found at [commonapp.org](http://commonapp.org);
2. Supporting documents, including transcripts and letters of recommendation.  
Please refer to [northeastern.edu/admissions/application-information/required-materials](http://northeastern.edu/admissions/application-information/required-materials) for specific requirements.
3. A verification letter from Rachel Goodman, director of community services at the BHA;\*

The application and all supporting documents must be received in order for Northeastern to make an admission decision.

If English is your second language, you may also be required to take the Test of English as a Foreign Language (TOEFL) exam, the International English Language Testing System (IELTS) exam, or the Pearson's Test of English (PTE).

*\*Candidates must submit a letter verifying their residence in BHA public housing within one month of submitting their admission application.*



#### THE APPLICATION DEADLINES ARE AS FOLLOWS:

- > **Early Decision:** November 1, 2015 (Decisions released by December 15, 2015)
- > **Early Action:** November 1, 2015 (Decisions released by December 31, 2015)
- > **Regular Decision:** January 1, 2016 (Decisions released by April 1, 2016)
- > **Fall Transfer:** April 1, 2016 (Decisions released by June 15, 2016)
